Thank you for choosing Banff Jasper Collection by Pursuit. To ensure that you understand the conditions of your booking, please read the following terms & conditions completely. Should you have any additional questions, please call us at 1.866.606.6700.

#### Lodging

Check-In/Check-Out: Times as follows: Check-In: 4:00pm / Check-Out: 11:00am.

**Parking:** Complimentary parking is available on a first-come/first-serve basis. Underground parking is available at Elk+Avenue and Chateau Jasper for vehicles under 6'1. Our front desk agents will advise of available parking and alternative options upon check-in.

Guarantee Policy: Your booking has been guaranteed to the credit card provided. If you are staying at Glacier View Lodge, a 50% deposit will be taken at time of booking. For any of our other properties, no charges will be placed on the card at the time of booking. A valid credit card is required at check-in.

**Taxes:** Please note that the rates are subject to 5% Good and Services Tax, 4% Tourism Marketing Levy and 2% Tourism Improvement fee. Subject to change.

**Quiet-Time Policy:** For the comfort and enjoyment of all of our guests, quiet-time will be strictly enforced between 11:00pm to 7:00am.

Environmental Programs: Elk+Avenue Hotel and Mount Royal Hotel participate in EcoStay. Each night you stay with us, a contribution will be made to EcoStay Motherland Forest on your behalf. This is a local reforestation project providing a unique parkland of carbon sequestration, wildlife habitat, education and cultural heritage.

**Cots:** Cots are available on a first come first served basis at select properties for an additional fee.

**Pet Policy:** All Banff properties are pet-free properties.

Jasper Properties allow Pets in select rooms for an additional fee. The policies for pets are as follows:

- · Limit of two pets per room.
- Small to medium size cats and dogs are preferred. Bigger breeds are welcome, provided they are calm and well behaved.
- Please keep your pets on a leash at all times in the public areas inside the hotel as well as around the exterior of our property
- Also be aware that Jasper has a "poop & scoop" bylaw you will need to abide by to avoid a fine.

- There are certain areas of the hotel where pets cannot be admitted. These include all restaurants, patios, meeting rooms and the pool areas.
- Should your pet have any accidents on the premises, please clean up after him or her promptly or ask for assistance if required.
- We would prefer that your pet not be left unattended in your room. If you need to leave without your pet, please inform the front desk and leave a contact number where you can be reached should your pet become agitated.
- Please arrange a convenient time with the front desk when you will be out of the room with your pet, so that our housekeeping team can service your room. Room may not be serviced if occupied by an unattended pet.
- Please do not bathe your pet in your room. The Front desk staff will be happy to direct you to a dog wash facility should you require this service.
- Any damages to the room, or excessive cleaning caused by your pet will be added to your credit card. Should your pet create a disturbance affecting the comfort of other guests, you will be expected to compensate the hotel for this loss of revenue.

**Smoking Policy:** Smoking is strictly prohibited inside the Hotel. A \$250 +GST fee will be charged per night (for the length of the entire stay) for smoking in a room.

Cancellation Policy: To cancel your reservation please notify us 48 hours prior to your arrival to avoid a cancellation charges being applied to your credit card.
Cancellation penalties within 48 hours will result in a charge for one night room and taxes. Failure to show for your reservation will result in 100% cancellation charge applied. Exceptions may apply.

Brewster Express and Sightseeing Cancellation Policy: Fully refundable based on changes and cancellations made up to 90 minutes prior to departure for Brewster Express services or 24 hours prior to departure for Brewster Sightseeing tours. Please always call to confirm your trip the day before departure. No payment shall be due or owing under these terms absent the provision of valid proof of identity to Brewster.

**Seating:** Seating is based on a first-come, first-serve basis. If you have a request based on special needs, please speak with your driver when you board the motor coach and we will do our best to accommodate your request.

**Pet Policy:** To maintain the comfort of all of our guests aboard, pets are not allowed.

Baggage Policy: The luggage or articles accepted and transported by Brewster Inc. are subject to the luggage policy and conditions as set herein. Guests travelling with Brewster Inc. are limited to two checked pieces of luggage per person. Total checked luggage weight per person is not to exceed 30 kg (66 lb.); excess luggage may be subject to a surcharge of \$25 per piece. Each piece of luggage must have an identification tag attached to it that includes name, return address, and telephone number. All guests travelling with Brewster Inc. should carry any medications or necessary belongings with them onboard the motor coach. Oversized items, e.g., sports equipment, may be subject to a surcharge. **Banff Gondola:** Plan on arriving 20 minutes prior to your departure time. Please ensure you are in line 10 minutes prior to your departure.

Lake Minnewanka Cruise: Plan on arriving 30 minutes prior to your departure time. The tour departure line is located by the boat house. Please ensure you are in line 10 minutes before your departure.

Columbia Icefield Adventure and Skywalk: Plan on arriving 20 minutes prior to your departure time. The Tour departure line is located on the main floor of the Icefield center adjacent to the main ticket desk. Please ensure you are in line 10 minutes prior to your departure.

Maligne Lake Cruise: Plan on arriving 30 minutes prior to your departure time. The tour departure line is located by the boat dock. Please ensure you are in line 10 minutes prior to your departure.

Maligne Canyon Icewalks: If riding on our guest shuttle, plan on arriving at the pickup location 5 minutes before your expected pickup time. If self-driving, plan on arriving at Maligne Canyon Wilderness Kitchen 5 minutes before your tour departure time.

If you miss your tour time, please check in at the Attractions desk to be re-booked for the next available tour time. Please note during peak periods tour availability may be limited.
