

BREWSTER EXPRESS – UNACCOMPANIED MINORS GUIDELINES
A DIVISION OF PURSUIT COLLECTION

THIS FORM MUST BE PROVIDED ALONG WITH UNACCOMPANIED MINOR AGREEMENT

It is the responsibility of the Parents/Guardians to ensure that the following guidelines are adhered to. Prior to boarding the coach the unaccompanied child and Guardians must understand that:

- / **The minimum age for a child travelling unaccompanied is 8 years old.** Any child under 8 years of age must be accompanied by someone at least 15 years of age.
- / **Unaccompanied Minors are only permitted to travel on the Brewster Express services.** Explore Rockies tours are unable to take part in a tour, without an adult accompanying.
- / The child must carry a copy of the Unaccompanied Minors Agreement with them while travelling.
- / The child must remain seated during the duration of the trip (excluding use of the washroom on board the bus).
- / The child must advise the driver immediately if s/he is being disturbed in any way or needs help.
- / Upon arrival at destination the child must remain on the coach until all other passengers have disembarked.
- / The child must speak with the driver prior to exiting the coach.
- / If two or more children between the ages of 8 and 15 (inclusive) are travelling together, they must each have a completed Unaccompanied Minor Agreement form.
- / The child is not permitted to get off the bus during stops; this includes a possible stop at the Brewster Transportation Centre in Banff.
- / The child must be met at the destination by the person specified on the Unaccompanied Minors Agreement form, there are no exceptions.
- / The Parent/Guardian identified to meet the child must present identification and sign the Unaccompanied Agreement form. It is the Parent/Guardian's responsibility to ensure the receiving party is informed of this.
- / The Parent/Guardian receiving the child must be at the destination 15 minutes prior to Scheduled arrival time.
- / The destination Terminal must be open upon arrival.
- / The Parent/Guardian must certify that the child travelling is aware of the guidelines and will adhere to them during travel.
- / A maximum of 3 children per family will be able to travel before adult supervision is required.

I (we) agree that I (we) will be responsible for any loss, damage, or injury whatsoever caused by the child or caused by the minor accompanying the child, and I (we) hereby agree to save harmless and indemnify Brewster Inc., and its affiliates, employees, directors, officers and agents for any and all such loss, damage, or injury. _____ (Initials)
6. I (we) agree that Brewster Inc. or any of its affiliated entities, employees, directors, officers and agents will not be held responsible for any loss, damage or injury suffered by the child or the minor accompanying the child before, during or after the trip detailed above, whether or not caused by the negligence of Brewster Inc. its employees, agents, officers, directors or affiliated entities. _____ (Initials)
